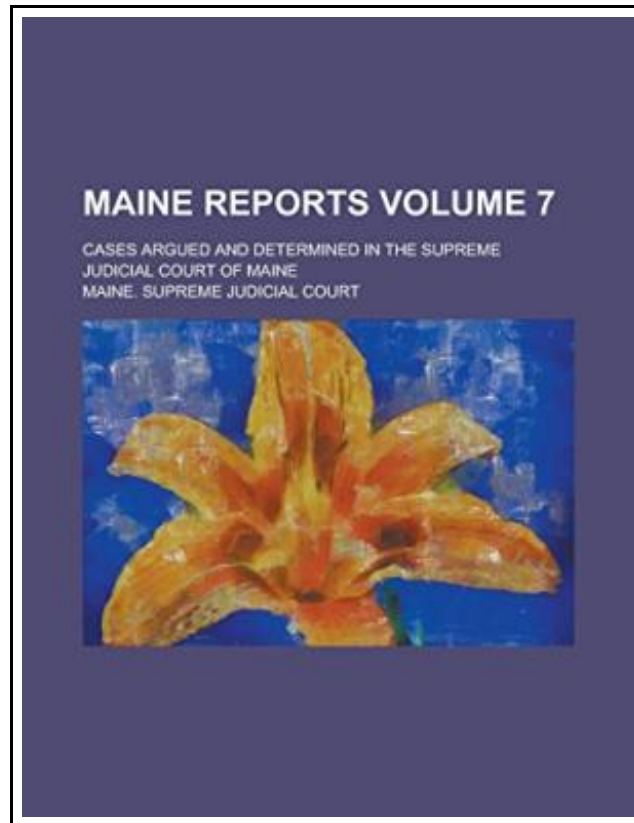

Excerpt: . . . should be damaged in his property by the opening of such new channel, and who should claim damages of the corporation, should deliver his claim in writing to the clerk of the proprietors, after which the corporation should be allowed ninety days to settle claim, before any complaint should be made to either of the courts for damages: Also that the corporators might erect mills on the new channel: And that all claims or right of action which individuals might have against the corporation or the members thereof, by reason of opening such new channel, should be barred and cease at the expiration of four years from and after the time when the cause of action accrued: --And that by another private statute, which they set forth, passed February 23, 1818, it was provided that the real estate of the original corporators should be liable for the damages occasioned by opening the new channel, only so long as they continued the owners thereof; and limiting the remedies for such damages to six years from and after the time the said Saco river shall have been turned and taken its course through the said new channel: --And thereupon they averred that the said persons thereby became a corporation accordingly; and at a legal meeting of the corporation holden September 29, 1817, and adjourned to October 13, 1817, they accepted said acts, and were duly organized as a corporation; on which last mentioned day they voted...
